The decree approves the amendment 3 of article 9 and the addition of article 35-B to the Organic Statute of the General Tax Administration, approved by Presidential Decree No. 324 / 14 of 15 of December, as amended by Presidential Decree No. 135 / 18 of 24 de Maio.

Section 36A of the Act introduces transfer pricing documentation requirements in terms of which: affected companies are to keep documentation explaining relevant transactions and confirming that the conditions in any transaction with a connected person are consistent with the arm's length principle; and companies whose transactions with a connected person exceeds BWP5,000,000 are required to file a master file upon request by the Commissioner General of the Botswana Unified Revenue Service (BURS).

Mozambique

Energy	Decree 54/2019 – The National Atomic Energy Agency	Issued on 14 June 2019.	 The decree: grants the National Atomic Energy Agency the mandate to act as the regulatory authority for the atomic energy sector; provides that the agency will be supervised by the Minister of Natural Resources and Energy and is responsible for supervising activities that: result in radioactive emission and waste; and relate to the use of ionizing radiation, materials, devices and radioactive substances across all sectors and entities.
